




Gifts and Benefits Disclosure Statement

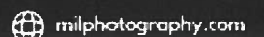
