About the program

- Service will be initiated once there is **more than 5 cm (2 inches) of snow** and after the Town’s plows have **completed** clearing the roads;
- Service is initiated 24 hours **after** snow has stopped falling;
- Due to the nature of winter operations, the Town cannot guarantee specific schedules for residential snow clearing
- Updates during winter storm events can be accessed online at www.ajax.ca or by phone at **905- 619-2529 ext: 4124**. In some cases, residents will be contacted by the Town of Ajax through a voice message service with information regarding when you can expect service to begin.

To qualify for this program, you must be:

A. Over the age of 65 with **no able bodied persons** under the age of 65 residing at this address;

OR

B. Unable to clear snow due to a physical disability, as indicated by a doctor’s note.

NOTE: A doctor’s note is required annually unless you have a **permanent disability** that has been identified by your doctor (documentation must be included with this application)

Snow removal services will begin seven days after your application has been processed

No refunds will be issued after January 1st, 2019

1. Snow removal service will begin seven days after this form has been processed
2. Snow removal service will be provided only when there is more than 5 cm (2 inches) of snow, and after the Town's plows have finished plowing the roads
3. Snow removal service will commence 24 hours after the snow has stopped falling
4. No refunds will be issued after January 1, 2019
5. Equipment used during snow removal could possibly result in surface damage to driveways consisting of interlocking, brick, patio slabs, uneven paving's, etc.
6. The Town of Ajax will not be responsible for damage to adjacent shrubs and landscaping on any private property of individuals receiving the snow removal service.
7. Properties will not be salted after driveway snow plowing has occurred , nor will residents be provided with salt
